## **Performance by Su-Tree Service**

Work crews shall arrive at the service location unannounced unless otherwise noted herein. Su-Tree Service shall attempt to meet all performance dates, but shall not be liable for damages due to delays from inclement weather or other causes beyond our control. Su-Tree Service shall perform care for or removal of trees specified.

## **Workmanship**

All work will be performed in a professional manner by experienced personnel outfitted with the appropriate tools and equipment to complete the job properly. Unless otherwise indicated herein, Su-Tree Service will remove wood, brush, and debris incidental to the work.

## **Insurance**

Su-Tree Service is fully licensed and insured (that is, all employees are covered by worker's compensation, and insured for liability resulting from injury to persons or damage to property).

## **Ownership**

The customer warrants that all trees, plant material, and property upon which work is to be performed are either owned by him/her or that permission for the work has been obtained from the owner. Su-Tree Service is to be held harmless from all claims for damages resulting from the customer's failure to obtain such permission. Su-Tree Service and its employees are not responsible for property or structures we are not made aware of. For example, for stump grinding to be performed, all utilities should be marked by the appropriate authorities. Failure to do so releases Su-Tree Service from possible damages incurred.

## **Terms of Payment**

Payment is due in full at completion of job. A service charge of 1.5% will be added to accounts not fully paid seven (7) days subsequent to the invoice date. If outside assistance is used to collect the account, the customer is responsible for all costs associated with the collection, including, but not limited to, attorney fees and court costs.

Extended payment terms are available if the customer furnishes a copy of his/her valid driver's license.
